  - i4c provides organizational advice.







#### **Collaboration with AURA FOUNDATION**



Since 2012 Invest for children has been committed to workplace inclusion for people with learning disabilities through operational and financial support for the Aura Foundation project.

The Aura Foundation is a non-profit organization founded in October 1989. It was initially conceived as an association and since 2004 as a private foundation.

The Aura Foundation was the first "Supported Employment" programme in Spain, a pioneer in the implementation and development of this methodology. Its mission is to **help improve the quality of life** of people with Down's syndrome and other intellectual disabilities, through **social inclusion in the workplace** following the bespoke Aura methodology.

The Aura Foundation is expanding its **telematic training courses**, to allow participants to acquire skills more independently. With the continuous support of trainers offering the necessary tools, and with continuous interactions with their peer group, which favours the teaching-learning process, the participants continue acquiring the necessary skills for working life.

The Aura Foundation offers different programmes for workplace integration of people with intellectual disabilities:

 Initial training with the intention of preparing candidates for the job and continuous training dedicated to cognitive improvement, learning to learn, improvement of written expression and reading comprehension, etc.

- Supported Living Programme: This programme focuses on offering the possibility to stay in a normalised environment with university students, learning to live together and to take on responsibilities that come from sharing a house with other people.
- The club is a community where participants can debate and defend their rights. It is a group of self-advocates who represent the beginnings of equality for people with disabilities.

#### **SAVINGS PLANS**



Since 2007, Invest for children has financed the Caixa-Bank Savings Plans, of which some of the participants of the Aura Foundation are beneficiaries, in recognition of their work and motivation.

Team Domenica strongly believes that young people with learning disabilities have the right to work, to lead fulfilling and purposeful lives, to have their individual gifts and talents recognised, and to feel included as valued members of society.

Invest for children sponsors Team Domenica's Wrap Around Programme, which **supports people with intellectual disabilities** in paid employment. This programme offers them a consultancy service focused on employment progression and is a source of advice for workers.

Founded in 2016 by Rosa Monckton, whose younger daughter Domenica has Down's Syndrome, Team Domenica helps young people with learning disabilities find and retain meaningful employment. Based in central Brighton & Hove, the organisation operates through a unique three-tier set-up of **Training Centre**, **Training Café** (Café Domenica) and **Employment Centre**. Through this they provide employment programmes to young people with a wide range of ability, referred to as their 'candidates' to more accurately reflect and emphasise their role as people ready for employment.

## SHE BISTRO

#### **Collaboration with BLUM FOUNDATION**

Invest for children has made a contribution to the Blum Foundation in order to promote the She Bistro project.

It is a project promoted by Cooking for Mission and Blum, which aims to offer opportunities to women survivors of gender violence and people with functional diversity through cooking as a means of training, employability, and community action.

On 19 October 2022, **She Bistro** opened its first **social restaurant in Barcelona**, which includes a chef and a head waitress as the only two non-vulnerable members of the team, as well as two people with functional diversity and six women survivors of gender violence.

The project is a commitment to the empowerment of **female victims of violence** and **people with functional diversity** through training and employment. In the first phase participants carry out internships in the hospitality industry and attend workshops on psychosocial support and skills. This offers them **support in the transition to permanent employment**, either through their employment in the restaurant or through partner restaurants and companies.

## HEALTH

Invest for children supports various projects that improve the quality of medical service and research. Our aim is to achieve a successful hospital stay for sick children and their families.



### PEDIATRIC CANCER CENTER BARCELONA

The Hospital Sant Joan de Déu provides comprehensive care for vulnerable people. With the support of Invest for children, The Hospital Sant Joan de Déu of Barcelona launched a major project to create the largest paediatric oncology centre in Spain and one of the largest in Europe. The centre opened in June 2022 and is almost fully operational, having already implemented its full range of services. The average occupancy rate has been more than 70% on the ward and around five patients have been attended to each day via the SJD home care programme for oncology patients. For outpatients there are 21 consultations and 26 day hospital cubicles. The first quarter ended with an average of 27 treatment sessions and 40 analyses per day in the Day Hospital area, which is open seven days a week. This is a similar volume as prior to the opening of the centre, however the new Day Hospital has freed up space previously allocated in the hospitalisation building, which can now provide a more flexible response to other specialities (including nephrology, allergy tests, immunology treatments, etc.).

The Surgical Block has two high-tech operating theaters. An average of six procedures are performed per day in the outpatient operating theatre. During the first quarter of 2023, it will be possible to open the second operating theatre, which will be able to perform complex oncological surgeries planned in 3D.

The SJD Paediatric Cancer Centre Barcelona also has a specific rehabilitation area, with materials adapted to patients' care needs, making it possible not only to attend to more children and adolescents at the same time, but also to absorb inpatient and outpatient care in the same place, where children can be attended to specifically by pathology and age groups.

Since opening, six of the eight chambers of the Haematopoietic Progenitor Transplant Unit have been enabled to respond to transplanted patients. The Nuclear Medicine floor will be operational from early 2023, which will occupy floor 0 and will have several units for diagnostic tests and two plumbed rooms for radionuclide treatments. This will prevent some patients from having to travel abroad, both to undergo certain tests and to receive specific treatments of this type.

Work is currently underway to complete the opening of the new paediatric oncology laboratories, which will bring together care and research activities. This area, which is scheduled to start up in the first quarter of 2023, encapsulates the new centre's comprehensive healthcare approach, based on holistic patient healthcare and the application of research to clinical practice whenever possible.

There is also an Oncology Pharmacy service specialized in dispensing guidelines for oncology patients, which will be complemented this autumn with the opening of clean rooms that will allow the preparation of medication in the same centre thus ensuring a higher degree of safety.



#### **Donation to ELENA BARRAQUER FOUNDATION**

Invest for children has made a contribution to the Elena Barraquer Foundation.

This Foundation facilitates access to ophthalmological care for people at risk of social exclusion, who are treated at the Barraquer Ophthalmology Centre and abroad through medical expeditions.

It also promotes eye health care through awareness campaigns, grants and scholarships for the training of ophthalmologists with limited resources and develops research projects.

Created in 1998, it aims to promote the development and evolution of children and adolescents with special needs, trying to increase their quality of life and integration into society, thus opening a path to a better future life.

The Association of People with Special Needs of Ibiza and Formentera (APNEEF by its Spanish acronym) is a non-profit association that brings together children and teenagers with special needs (physical, mental, sensory and/or cognitive disability).



#### **Collaboration with PORTAVENTURA FOUNDATION**



In 2022, Invest for children made a contribution to the PortAventura Foundation's Dreams project.

PortAventura Dreams is a programme that offers a free six-day stay to children between the ages of 4 and 17 who have suffered or are suffering from serious illnesses, so that, together with their families, they can enjoy an unforgettable and renewing experience.

Dreams Village occupies 8,850 m<sup>2</sup> with six homes equipped to accommodate around 200 families each year.

### Invest for children supports various projects that improve the quality of medical service and research



The stay includes access to all three PortAventura World parks; in addition, to offering a unique experience. It has recreational-therapeutic activities that encourage moments of family togetherness, play areas, a football pitch and multi-purpose rooms for children to meet other children with similar life stories.

### We promote the achievement of further education and vocational training

### **EDUCATION**

People with learning disabilities are able to pursue their studies in a standard way. Invest for children promotes higher education or vocational training so that people with intellectual disabilities are highly gualified and prepared for the workforce.

### **eterral UNIVERSITY SCHOLARSHIP** terral.org

In 2022 Invest for children awarded its third university scholarship for a student from the El Terral Foundation in Ciutat Vella to study for a degree in Industrial Engineering Design and Product Development.

"El Terral" is an activity centre in the Raval district of Barcelona promoted by Raval en acció, assoc., where programmes are developed to provide socio-educational support to young people and women, most of whom are immigrants. Resources are offered to facilitate their integration into the labour market. In order to carry out the programmes, volunteering is promoted among students and professionals.





#### **Collaboration with VIJAY AMRITRAJ FOUNDATION**


## SOCIAL INCLUSION



#### **DOWN TV**

**Down TV is the first video-sharing platform dedicated** i.e. health workers, teachers, employers, etc. exclusively to Down's syndrome.

Down TV is aimed not only at people with Down's syndrome, who can upload their own videos and express themselves to the world, but also, and in a special way, at their families and professionals related to Trisomy 21,





Down TV offers a free service, visually increasing awareness of this genetic alteration and its capabilities. DOWN TV was created in 2010. It has more than 3,000 videos uploaded to the website.

#### **Collaboration with EL TERRAL DE CIUTAT VELLA FOUNDATION**



During 2022, Invest for children assumed the maintenance and operating costs of two mineral water fountains at the offices of the El Terral Foundation in Ciutat Vella (Barcelona), as it has been doing since 2012.

- Promotion and training of volunteers. Terral provides the necessary preparation, advice, and follow-up to each volunteer so that they can effectively carry out their task. Volunteering is promoted among university students, professionals, and retired people.

Terral is a group of volunteers who develop the Raval en Acció project, aimed at providing socio-educational support and facilitating equal opportunities and social cohesion.

Terral's objectives are:


#### Promotion of women.

In an atmosphere of freedom, trust, and dialogue, Terral encourages personal improvement and provides a basic preparation that facilitates the employment, inclusion and social adaptation of girls, teenagers, and women.

Their programmes promote the educational, social, and cultural cohesion of new arrivals, while respecting and valuing the different contributions of each participant.





#### SINDROME DE DOWN CATALUNYA FOUNDATION





In 2021, Invest for children continued its collaboration with Down Catalunya, with the aim of dedicating a day to organisations that work for the social and occupational inclusion of people with learning disabilities, albeit open to everyone.

On 8 October 2022, the Fent Amics day was held at PortAventura Park.

### SPORT



**Collaboration with SPECIAL OLYMPICS SPAIN** 

In collaboration with Special Olympics Spain, Invest for children aims to add a new sport to the Special Olympics Spain sports portfolio.

Thanks to the development of paddle tennis schools, athletes with intellectual disabilities will train and compete in this new sport. It is a 3 year project with the aim of progressively increasing the number of participating schools and athletes. In 2020, new paddle tennis schools were opened and in 2021 it was possible to organise the 1st National Paddle Championship for athletes with intellectual disabilities in Castellón:

Almost 50 athletes with and without intellectual disabilities from Aragón, Castilla y León, Madrid, the Region of Murcia and the entities representing the host community, UNITTS CD, APDA and SinDown Castellón, put the skills acquired from the Paddle Schools to the test. By 2022, the programme has 8 schools in 5 autonomous communities that give more than 100 athletes the chance to play paddle tennis.

- The competition was attended by almost 50 sportsmen and women with and without intellectual disabilities, coming from five autonomous communities.

- Beyond the competition, the weekend was completed with a welcoming act and a closing ceremony.

#### **Collaboration with ALEX FOUNDATION**

In 2022, Invest for children made a donation to the Alex Foundation in favour of the Atlètic Lleida Genuine sports project.

With this Project, Lleida has a Genuine football team that began its journey in the 2022-2023 season.

LaLiga Genuine Santander is a football competition for people with intellectual disabilities in Spain. It is organised through the LaLiga Foundation and represents professional football's commitment to diversity and inclusion. The first edition was held in 2017.

Invest for children participates with the Fundación Tenis Barcelona through its programme "Tenis con valores" (Tennis with Values).

The Real Club de Tenis Barcelona 1899 is a club with more than 120 years of history and closely linked to the city of Barcelona, especially through the Conde de Godó Tournament. In 2019 it decided to take a new step by creating the Tenis Barcelona Foundation to promote and expand the existing solidarity activities.

The "Tennis with Values" programme was launched in the spring of 2020, with a small group of boys and girls from the Casal de Adolescents de la Barceloneta. During the academic year, the programme offers weekly solidarity tennis sessions for children and young people at risk of exclusion, with tennis lessons on municipal courts in the city's neighbourhoods. They transmit the values of tennis, equip them with the


This programme aims to have a Solidarity Tennis School with at least 400 participants by the end of 2024. During the 2021-2022 academic year, more than 100 tennis sessions have been offered and more than 900 snacks have been distributed. The "Tennis with values" summer school has had more than 180 beneficiary children and more than 30 hours of tennis.

## 6. AUDITOR'S REPORT

#### Informe de Auditoría de Cuentas Anuales Abreviadas emitido por un Auditor Independiente

Al Patronato de Invest for Children Fundación Privada

#### Opinión

Hemos auditado las cuentas anuales abreviadas de Invest for Children Fundación Privada (la Fundación), que comprenden el balance abreviado a 31 de diciembre de 2022, la cuenta de pérdidas y ganancias abreviada, el estado abreviado de cambios en el patrimonio neto y la memoria abreviada correspondientes al ejercicio terminado en dicha fecha.

En nuestra opinión, las cuentas anuales abreviadas adjuntas expresan, en todos los aspectos significativos, la imagen fiel del patrimonio y de la situación financiera de la Fundación a 31 de diciembre de 2022, así como de sus resultados correspondientes al ejercicio terminado en dicha fecha, de conformidad con el marco normativo de información financiera que resulta de aplicación (que se identifica en la nota 2 de la memoria abreviada) y, en particular, con los principios y criterios contables contenidos en el mismo.

#### Fundamento de la opinión

Hemos llevado a cabo nuestra auditoría de conformidad con la normativa reguladora de la actividad de auditoría de cuentas vigente en España. Nuestras responsabilidades de acuerdo con dichas normas se describen más adelante en la sección Responsabilidades del auditor en relación con la auditoría de las cuentas anuales abreviadas de nuestro informe.

Somos independientes de la Fundación de conformidad con los requerimientos de ética, incluidos los de independencia, que son aplicables a nuestra auditoría de las cuentas anuales abreviadas en España según lo exigido por la normativa reguladora de la actividad de auditoría de cuentas. En este sentido, no hemos prestado servicios distintos a los de la auditoría de cuentas ni han concurrido situaciones o circunstancias que, de acuerdo con lo establecido en la citada normativa reguladora, hayan afectado a la necesaria independencia de modo que se haya visto comprometida.

Consideramos que la evidencia de auditoría que hemos obtenido proporciona una base suficiente y adecuada para nuestra opinión.

#### Aspectos más relevantes de la auditoría\_

Los aspectos más relevantes de la auditoría son aquellos que, según nuestro juicio profesional, han sido considerados como los riesgos de incorrección material más significativos en nuestra auditoria de las cuentas anuales abreviadas del periodo actual. Estos riesgos han sido tratados en el contexto de nuestra auditoría de las cuentas anuales abreviadas en su conjunto, y en la formación de nuestra opinión sobre éstas, y no expresamos una opinión por separado sobre esos riesgos.

Reconocimientos de las ayudas concedidas (véanse notas 4.7 y 17 b.2))

La Fundación reconoce los gastos por ayudas concedidas en el momento en que se otorgan, previa aprobación por parte del Patronato. La determinación del reconocimiento de las "Ayudas concedidas" es un área de significatividad por lo que se ha considerado un aspecto relevante de la auditoría.

Nuestros principales procedimientos de auditoría han comprendido, entre otros, el entendimiento del proceso de otorgamiento de ayudas y, para una muestra de ayudas concedidas, hemos comprobado la correcta imputación temporal del gasto en el periodo apropiado, así como los correspondientes justificantes de pago. Adicionalmente, hemos evaluado si la información revelada en las cuentas anuales abreviadas cumple con los requerimientos del marco normativo de información financiera aplicable a la Fundación

#### Responsabilidad de los miembros del patronato en relación con las cuentas anuales abreviadas
